Director's report

- Library Operations
 - Computer usage was up; WIFI usage continues to increase
 - Adult circulation was up from last month
 - New library cards users numbers is up doubled from last month
 - 27 people participated in our Halloween Goodies
 - The Township stopped over to go through the checklist.
 - Keith is going to refurbish the drop boxes, the front entrance floors are going to be buffed they came and got an estimate (december 11th)
 - We discussed repaying the parking lot. We would like to first replace the digital outdoor sign. It will need to be done prior to the repaying, due to electrical work.
 - The kitchen sink was fixed
 - Weather strip has been replaced in the kid's play area (insects keep creeping in).
 - LED lights are on the list for replacing lights, this will help us reduce our energy bill.
 - We are currently getting estimates for replacing the carpet

- Security cameras are a doable solution for the community room for safety purposes.
- Bathroom door locks are in the works. The changing table has arrived, and we are working to have it installed.
- Outdoor reading area is still a possibility, going to revisit it in the spring.
- Staff in-service we discussed some fundraising ideas. We are in the works

- Section 2.4 Nomination and Election: Trustee slots will be filled by appointment from nominees put forth by the Library Board of Trustees and confirmed by the Board of Supervisors of one of the service area townships.
- Prospective trustees should attend a minimum of one board meeting before they are eligible for election onto the board.
